Free School Meals

£1,345 Available to Help your Child in School

We want to make sure that we are providing your child with the best education and support we can. Healthy school food has health benefits and can help pupils establish healthy habits for life. Healthy school food can also help to improve pupils' readiness to learn.

Families who receive certain benefits may be eligible for free school meals. Registering for free meals could also raise an extra £1,345 for school to use to help children.

It does not matter if your child does not want the free school meals or if they already get a free school meal in KS1 through the Universal Free School Meals scheme. The money is available in school to help children from these families. All applications and information is confidential and we would like to encourage everyone to claim their entitlement.

If you earn less than £16,190 annually and claim any of the benefits below, please do apply:

- Universal Credit with an annual net earned income of no more than £7,400.
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Child Tax Credit (with no Working Tax Credit) with an annual income of no more than £16,190
